The Provost's Council discussed a change in the graduate assistant tuition policy that would make employing units responsible for the tuition scholarship for GA appointees outside their home college unless the home college and employing unit have reached some other agreement. The default however, would be the employing unit is responsible for tuition scholarships for outside home college appointees. The change in policy has not yet been approved, but sentiment among the deans was strongly supportive. If approved, it would be effective FY 17 to allow units that appoint GAs to plan appropriately. I expect this issue to be considered again, and a decision likely reached, at the April 29 meeting of the Provost's Council. Any comments or suggestions can be sent to Holger.

William Graves, Associate Dean

Deadlines for submitting POSC. Current – future. Current policy says POSC needs to be approved before end of the semester in order to graduate the next semester. Options could be to loosen deadline to the end of the semester. When Grad College "flips the switch" for POSCs to be approved automatically, fewer POSCs will be stopping at the Graduate College. Graves would like feedback as to whether the policy should allow late submissions of POSC. Council may want to consider changes to policy. Think about big picture of the policy. Discussion: There has been a large influx of master's students, especially coursework only or creative component. Two months may appropriate time frame. Coursework only may need to be different.

Discussion notes: Nothing was in place before for the grievance process. All is new. Remove one of the two Step 3s. All parties can appeal. Question: One department refers to as PostDoc Trainees. Handbook refers to D base as Scholars. Names should be consistent. Grievance is if a PostDoc feels a wrong by the faculty member. Graduate College has oversight over all PostDocs, not VPR. The Graduate College could consult with VPR or anyone else regarding grievance. No grievance process under Human Resources as employees. The wording for the dismissal process was slightly changed to include a written notice with steps and timeline and to establish expectations in writing. Timeline will be left up to

the PI. Notice of dismissal – one month timeline. This is to use before their LOI expires. Vacation time has to be used by the end of the year, it does not accrue. Use it or lose it. There is a benefits section in HR for post docs. Ogilvie will make changes. Vote by e-mail.

The sense at the DOGE meeting was that it would be a good idea to develop a potential policy regarding use of iThenticate for dissertations and theses, and that further discussion of the draft should then occur on a fairly broad basis. David Holger, Associate Provost and Dean

- Graduate Council relationship with Faculty Senate. One policy generated lots of interest outside of the Graduate Council. That policy was related to the use of undergraduate classes on a graduate student's program of study. The Faculty Senate is concerned about this issue. It is important to communicate potential policy changes to the Graduate Faculty members and the Faculty Senate.
- Welcome to the new members. The Graduate Council plays an important role for Graduate Policies and Procedures. It is the final deciding body of faculty members.
- This fall, graduate enrollment set a record high. Graduate students increased by 200. Post Doc positions also increased. The goal is to keep the graduate student population growing. Student associations have been more active and that helps with recruiting. This year, the ISU Administration has paid more attention to graduate programs than previous administrations.

- Graves reviewed discussions with college IT professionals regarding faculty members participating by distance for preliminary or final exams. Current policy one faculty member at a distance. There are increasing requests for waivers. The Graduate College has heard horror stories about technical failures where faculty members are not able to finish the exam. This summer Graves and Strand met with IT leaders from colleges about latest technology for distance participation. Graves is in process of developing best practices for conducting meetings with member are a distance. This is a possible Graduate Council sub-committee topic.

Background for undergraduate classes used for a graduate program

Whereas:

- Critical review of undergraduate courses proposed as eligible for non-major graduate credit is, at best, spotty across campus.
- Existing courses that provide non-major graduate are not subject to periodic review.
- There are no policies on standards for courses offered for non-major graduate credit.
- Graduate faculty status is not required to teach a course that provides non-major graduate credit.
- Approximately 92% of programs of study include seven or fewer non-major graduate credits, and no more than 5% of programs of study include non-major graduate credits from 300-level courses.

Approved by the Graduate Council September 26, 2013

- All 300- and 400-level courses shall be eligible for use toward graduate degrees, and the phrase "non-major graduate credit" will no longer appear in course descriptions in the catalog.
- With approval of the program of study committee, up to **three** courses at the 300 or 400 level may be used to meet the requirements for a graduate degree.
- No more than one **course** from 300-level courses may be used to meet the requirements for a graduate degree, and any credits at the 300 level must be from outside of the student's major.
- This policy will apply to all graduate majors and will replace unusual practices, such as this one in history:

Graduate Study

Graduate students may take any 400-level history course except 490 and 495 for graduate credit. There is a maximum of 12 credits of 400-level courses for a graduate degree in history. Additional work is required for graduate credit in 400-level courses.

• No 300- or 400-level courses may be used to meet the requirements for graduate certificates.
